REPORT

This was a very successful meeting. Professor Danny Dorling (University of Sheffield) was invited to be one of the key-note speakers and following acceptance of our invitation the first call for papers was sent out in April 2008. We also invited Professor Andrew Clark (Paris School of Economics) to be the second key note speaker and he accepted our invitation in July 2008. The deadline for abstract submissions was set for the end of July and more than 50 papers were received as a result of the wide circulation of the initial call for papers. Given the high number of papers that we have received we decided to organize parallel sessions that would allow us to accommodate as many sessions as possible in one day. The scientific committee comprised Dimitris Ballas, Silvia Grandi, Vasilis Monastiriotis, Gianluigi Pelloni and Theodore Panagiotidis. The quality of the papers submitted was the sole criterion of assessment and on that basis the scientific committee chose 25 papers in total out of the more than 50 papers that were submitted. The final programme of the workshop can be found at the above web site as well as in the end of this document. The seminar participants were from a number of European countries representing universities such as the London School of Economics, the University of Sheffield, the Paris School of Economics, University of Bologna, the Institute of Advanced Studies in Vienna, CORE (Louvain), the Graduate Institute in Geneva, the University of Nottingham and the University of Athens among others.

The high quality of the papers presented have triggered a lot of stimulating discussions and resulted in discussions for the need to have a special issue out of this workshop. The editor and associate editors of the *Review of Economic Analysis* offered generously the space needed for this. The call for the special issue is available in the web site and in the end of this document as well.

Although the stakes are high and the success of the first meeting make our job difficult we are committed to organizing an even better workshop in Rimini in Italy in May 2009.
